Mayor Baird called the meeting to order at 7PM

Councillor Patten moved to accept the agenda has presented, seconded by Deputy Mayor Carter all in favour, motion carried.

Deputy Mayor Carter move to accept the minutes of June 2, as presented seconded by Councillor Patten, all in favour, motion carried.

RCMP – Report from residents of speeding through town. – Corporal Turner of the RCMP Glovertown detachment attended the meeting as invited by Council to discuss the speeding problem in Traytown. He indicated that the RCMP will increase patrols in Traytown to curtail speeding. He suggested that the Town contact the Department of Transportation and request more speed limit signs. Also suggested that the Town put a notice on the Community Channel that the RCMP have increased patrols in Traytown. He said signs are important, especially for visitors without any knowledge of the speed limit. However, it more often local residents who are found speeding. Inadequate speed limit signage is often used as a successful defence against speeding tickets. Council decided as well to place a sign on its poster board to n notify people coming into town that the speed limit through town is 50kph. Council will put an ad on the television channel informing people that the RCMP have been notified and will be enforcing the speed limits.

<u>Therefore it be resolved</u> that on the <u>23</u> day of <u>June</u>, <u>2014</u>, we (Traytown Council) passed the resolution which provides the Whey Group to do a Feasibility Study on the amalgamation of the two towns.

QUARRY – Request from Leonard Warfield, Adam's Enterprises to release the quarry permit applications. **Approval at Special meeting on June 23, 2014**

Request from Oram's Do All for exploration (testing). Natural Resources Inspector and Manager met with council on Wednesday May 14, 2014. Council requested overlay maps to show existing pits and applications relative to zoning boundaries.

Due to the council not having adequate control over pits and the excavation activities in the Mineral Workings zone, Traytown Council is proposing to change the zoning of the area to Rural. This will mean that pits already in existence will be under the grandfather clause but development of any new pits will be at Council's discretion

Deputy Mayor Carter moved to move ahead with an amendment to rezone the Mineral Workings zone to Rural, seconded by Councillor Patten all in favour motion carried.

Mayor Baird will prepare the amendment as soon as possible.

There is still garbage being dumped into the Ploughed Ground Road area, buckets of animal feces placed in garbage bags have been found in several areas. Council will have to install cameras to curtail the activity. Council will keep an eye on the area to see if it continues. Councillor Janes has a camera that council can use if they require it. If the camera gets stolen council would reimburse Councillor Janes the cost of his camera.

2014-15 municipal Capital Works Program Project No. 17 -MCW-15-00076 Road Upgrading – Three prices have arrived 1. Cecon - \$9,469 + H.S.T.; 2. DMG - \$9.722 + H.S.T. included and Meridian - \$16,400.00 + H.S.T. The breakdowns of the prices by the two lowest companies are not comparable due to soil testing being included in only one of the prices. Mayor Baird will contact Mr. Angus Bradley, Municipal Affairs to find out if the testing is needed and if it is the clerk will contact Cecon and ask if their price includes soil testing.

Mayor Baird declared a conflict of interest on this decision, and will not participate in the selection of a consultant.

ENVIRONMENT SPILL The clerk left a message with the adjuster of the accident with the information she requested but is still waiting on insurance to make a discussion. Council has not received an invoice from Sunnyside for the hazardous material that the town had to take to the site.

NEW BUSINESS

PERMITS - -Application for crown land Pine Tree Road – same land that was applied for in 2012 by another resident but was not completed, Council does not approved this application due to – the land is not adjacent to the individuals land and does not confer with the Town Plan, the land must have a 30 square meter frontage and 1860 square meter area to use for building. The land area is smaller than the plan requires and the individual wants it to use for storage.

Application for crown land Main Street Aspen Drive next to old school property, this land cannot be approved until it is confirmed that the individual is planning on building a house on the property, the application states garage and vegetable garden. The clerk will contact the individual and confirm that he is using the land as per the town plan. Deputy Mayor Carter moved to approve the crown land application upon confirming that the land will be used for the construction of a house, seconded by Councillor Janes, all in favour, motion carried.

Application to Build a porch 12 x 18 @ 5 Pine Tree Road. **Deputy Mayor Carter** moved to approve the application to build a 12' X 18' porch at 5 Pine Tree Road, seconded by Councillor Janes, all in favour, motion carried.

Application to build extension 12' X 28 1Ž2' on 9 Balsam Lane – **Deputy Mayor** Carter moved to approve the application to build a 12' X 28 1Ž2' extension at 9 Balsam Lane, seconded by Councillor Janes, all in favour, motion carried.

A letter arrived from CPAA, Canadian Postmasters and Assistants Association, was received on July 8, 2014 requesting a resolution of council against Post Office reduction in hours as well as petition for residents to sign against reduction in hours. The clerk will place the availability to sign the petition on the local ad channel for any residents that wish to sign it.
