## **BUSINESS ARISING FROM SPECIAL MEETING JULY 23, 2015**

QUARRY PIT APPLICATION – Council met on July 23, 2015 to discuss an application from Station Road Contracting Limited to Natural Resources for a pit in Ploughed Ground Road. The pit is located next to and includes what is known has the old ball field. The company has its Business Tax paid in full the area is inside the boundaries of the Mineral Workings. Council will approved this pit if Station Road Contracting agrees to sign a Memorandum of Understanding. Mr. Hiscock agreed to sign the MOU. Deputy Mayor Carter moved to approve the quarry for Station Road Contracting with the MOU signed, seconded by Councillor Janes, all in favour, motion carried.

The ditching has not been assigned for this year, the clerk will inform Mr. Hiscock that the ditching will be carried over to next year if it is not done before the end of August.

<u>AMALGAMATION</u> – Two meetings had been scheduled and canceled with Glovertown in the last month, the clerk will call Glovertown and arrange a new meeting date.

<u>GAS TAX</u> – Ms. Hanchar has sent a copy of the Terms of Reference to council for their review, Mayor Baird will go through the forms and try to have it ready by the end of the month to go out to tender.

<u>CAPITAL WORKS PROJECT</u> - The clerk will contact Tracey Bates Eisan, DMG Consulting Limited and ask her for the preliminary drawings for the road work.

RECREATION REPORT – Councillor Denty absent

<u>STUDENT EMPLOYMENT – Two students hired to paint Town Hall (inside)</u>, rink railings (top and bottom), bus shelters, patio, back steps, mow grass, and cut alders. The clerk will purchase new alder cutters for the students.

#### **NEW BUSINESS**

**COMPLAINT GARBAGE PLOUGHED GROUND ROAD** – The clerk was emailed pictures of the debris dumped into different areas of Ploughed Ground Road. Council will get a price from Kimberly Ralph for the cleanup of the area and a price for cameras to be placed into the area to

find out who is dumping garbage in the area. Two signs will be purchased from Sign Factory to inform the public of the cameras in the area. **Deputy Mayor Carter moved to purchase signs and cameras for the area, seconded by Councillor Janes, all in favour, motion carried.** 

AUDIT – Deputy Mayor Carter moved to approved the 2014 audit as presented, seconded by Councillor Patten, all in favour, motion carried.

PROPERTY TAX DISCOUNT Councillor Pattern moved to approve the discount of 50% for female senior in the amount of \$128.08, seconded by Deputy Mayor Carter, all in favour, motion carried.

POSTER BOARD SIGN – The poster board sign on Main Street has been vandalized again. Repairs and painting have been done but the sign still needs a lot of work. Council will ask Tony Ferguson, Sign Factory, if he would like to take ownership of the sign. Councillor Janes moves to pass over sign responsibility to Tony Ferguson if he agrees, seconded by Deputy Mayor Carter, all in favour, motion carried.
