## Taxes and Fees

#### 2020 Taxes & Fees Structure

#### **Residential Land**

Mill Rate – 4.0 mills Minimum per property -\$225 Garbage Rate-\$71 Sewer Rate-\$250

Homeowners may apply for a low-income discount. Call the Town Clerk for information.

#### **Vacant Land**

Mill Rate - 4.0 mills Minimum per property -\$225

### **Commercial Land**

Mill Rate - 2.1 mills Minimum per property -\$225 Sewer (Cabins) -\$ 50/unit

#### **Business Tax**

Mill rate - 2.3 mills Minimum per business - \$335 Home Based Business - \$335

Home Based Business may apply for the following discounts.

- Net income of \$6,000 -\$10,000 - 33% reduction
- Net income of \$3,001 -\$6,000 - 66% reduction
- Net income of less than \$3,000 - no tax

#### **Quarry Permits**

\$1000 per operator

#### Utilities

2.5% of Gross Revenues

## **Permit Fees:**

Building Permits - \$25 General Repairs - \$10 Sheds / Garages - \$10 Tax Certificates - \$100

Tax Due Date: June 30, 2020. If not paid at that time there will be a monthly interest charged on any money owing.

## Council Meetings

Council's regular monthly meeting takes place on the first Monday of every month. Due to work schedules and other obligations this sometimes has to be rescheduled.

# Tax Arrears from Previous Years

Thank you to all the tax payers who are making a worthwhile effort to pay their taxes. It is very much appreciated. Arrears are steadily coming in and it seems that tax collection by courts, etc. are at an all time low. The town can now place a lien against any property in arrears to the town which would interfere with selling, transferring or giving your house to another person. Notices of these actions were placed in the mail this month taking people to court for all arrears owing. 2020 invoices are being prepared now.

Anyone who believes that they are eligible to receive a property tax discount should contact the Town Office for the application form. Eligible discounts depends on the total income in your household.

- \$0 \$20,000 50%
- \$20,001-\$22,000 45%
- \$22,001-\$24,000 **-** 40%
- \$24,001-\$26,000 **–** 35%

\* Only Property Tax can be discounted and the minimum payment is \$296.00 for Property and Garbage Tax. This does not include Sewer Tax.

## Water & Sewer

In 2018 the town contracted the Wood Group to assist with finding a suitable town water supply. A location was found and two commercial quality wells were dug in December 2018. These wells have capacity for more than enough water to supply our town!

Council was subsequently approved for \$2.25 million of capital works funding for Phase 1 of our proposed water and sewer project. The Provincial and Federal Governments will cover 90% of this cost and the town will be responsible for 10%.

Funding to cover the town's capital share would come in the form of a new Water & Sewer Tax to residents and an increase of up to 1.0 mil in property taxes. An initial estimate of the annual Water and Sewer Tax is \$450 per residence.

All property owners will be responsible for the water and sewer connection from their house to the roadside water main. Water and Sewer bills will be issued once the water main passes each residence, and would be pro-rated for the time remaining in the tax year.

## House Numbering

Council has sent the town map and information of the new numbering system to 911 emergency response system. Your old number will no longer be acknowledged. The new street addresses assigned by the Municipal Assessment Agency in 2015 is now in their system. As seen on your Property Tax Assessment and tax invoice, not all numbers have changed but most have. Please make your street number clearly visible in front of your property for emergency responders to see when trying to locate your home. This is the only number they have on their map so know your new number and please update it ASAP.

## Tax Payments

Please be advised that the town has set up a payee account for anyone who cannot get into the office with payments. When doing your online banking go to bills under payee and find TRAYTOWN (TOWN) and use

your Municipal Assessment
Agency Parcel ID number as your
account number. Your number is
shown on your property
assessment that came out in
October as well as your town tax
invoice that comes out in
January. The first three numbers
of the Parcel ID number is 263-.
If you cannot find it contact the
town office to get your parcel ID
number.
