ACCEPT MINUTES OF January 4, 2021/ January 12, 2021 and January 18, 2021 [attached] moved by Deputy Mayor Baird, seconded by Councillor Janes all in favour, motion carried.

## **BUSINESS ARISING FROM JANUARY 4, 2021**

Capital Works — DMG has informed council that they would have something ready for council to go through formal approval by February 8, 2021 Council may have to call a meeting with them before the next regular meeting. The surveyor, Scott Murphy has been hired to survey the areas needed for the easements, for the road to the tower as well as the right of way to bring the pipes from the back area to Pine Tree Road. Councillor Harmon will contact Mr. Murphy to get an update on the two pieces of land needed to install the water and sewer first phase. Mr. Murphy was contacting Newfoundland Power to ask if it was possible to follow the power line easement from the wells to the cemetery he has not informed council of the information at this time. The time line is crucial to the work to be carried out so council will have to make sure everything stays on schedule or close to it.

CBLC – has inform council that the hydraulic surveyors are going to check water heights from Pissamare Pond and surrounding area. The crown lands application is waiting for approval.

Financial Report — Town Clerk, Mayor and Deputy Mayor attended the bank and opened up new account and gave permission to have the other two accounts moved to Glovertown. Waiting on the auditor to arrive on Wednesday to set up the three accounts on the simply account system. The bank has offered a new system for the town to operate all three accounts by having a card for the accounts. The card will enable the Clerk Manager to manage the three accounts when necessary. The Gas Tax account will be used only to transfer the alloted amount that has been approved while the Municipal Capital Works account will be used to pay for all the Capital Works Projects that are approved. The Chequing account will now be used to deposit all funds so that they will be transferred to the proper accounts when necessary. The card will only be able to be accessed by the Clerk Manager and when she leaves the card must be destroyed and a new card given to the next person who takes on the position. Councillor Harmon moved to apply for the

card for the town, seconded by Councillor Janes, all in favour, motion carried. The clerk Manager and Mayor will attend the bank to set up the accounts.

**Stimulus Funding** – Report from Wharf Project: Resolution brought forward to use gas tax. Attached to minutes.

Budget – 2021 Budget Approval brought forward and waiting on Municipal Affairs approved by Deputy Mayor Baird seconded by Councillor Harmon all in favour, motion carried.

#### **NEW BUSINESS:**

Permits - Permit to operate a band saw and erect a structure at 11 Aspen Drive, Councillor Harmon moved to approve the Application to Build for a bandsaw and structure at 11 Aspen Drive, seconded by Councillor Janes all in favour motion carried.

**Deductions:** - Home Based Business request exception for 2020 did not operate due to Covid- 19 and will not operate until further notice. Total income from January to March \$7163.32, Councillor Patten moved to exempt the Home Based Business for 2020 Seconded by Councillor Harmon all in favour, motion carried.

Parks Canada – Mayor Carter met with other town officials and Parks Canada (virtually) to discuss concerns: The intersection from the TCH to the towns of Eastport, Traytown, etc. was discussed and there are some grave concerns with this intersection, there have been five Fire Rescue emergency calls for the Jaws of Life since the change has taken place. The road before the change allowed people to exit onto the highway going west to a merge, which now contains a stop sign and no merge, the speed limited in this area used to be sixty kilometers per hour and it is now eighty, there is no signage showing the traffic that the through lanes are for fast drivers and the slow lane is for slower traffic, at night and or when snow covered the driver can't see if they are parking on the turning lane or the passing lane due too dark or covered to see the arrows. The clerk Manager will write Parks Canada a letter requesting that this area of the TCH be changed to keep people safe.

**Recreation:** Councillor Harmon meet with Traytown Recreation on Sunday January 24, 2021 and a name for the other park was discussed. The name council had agreed on was Head and Nose Park a name that came from years ago when that area was called Head and Nose Point. The committee has been approved for \$500.00 from Recreation NL to install signage around town showing the names and areas around the town like Woodrock Park Pissamare Pond, etc. The group as approximately \$9,700.00 in their bank account and will be doing repairs to the rink as well as building a tool shed in their vegetable garden.

**Wharf** – Council will have to discuss the signage for the wharf as well as the slip way in the coming months to decide on the amounts that will be charge for using the facility as well as fee for docking the boats at the wharf.
