BUSINESS ARISING FROM September 13, 2021

1. Capital Works - Reports - Crown Land - All crown land has been registered and paid for as well as all easements except for those on Juniper behind Wilfred Wyatt's and Colin Smith's house which will have to be done soon to continue with Phase II. Fencing prices- there has been garbage dumped into "Tucker's Pit" and burned, a fence around the wells has been priced in the specs for the first phase of the water and sewer project, council will have their contractor Station Road Contract dig a ditch and pile the contents in front of the ditch on the road going into Tucker's Pit for the winter until the work begins on the fence. The clerk manager will also order a ROAD CLOSED sign from Sign Factory for the area. Cameras prices - Glovertown has cameras with reporting system to their computers with a cost of over \$10,000, but there are about fourteen cameras around their town. The camera system was install by Simple Logic St. John's Jason Howse was the contact person. The Clerk Manager will look at a more affordable option for the town. Test wells – Councillor Harmon has taken the information from the test wells and has sent it to Colin Walker, CBCL for review. It seems the well water supply is down with the dry summer. Sewer inspection cost turned down by Gas Tax, but the town Clerk Manager will talk to Mr. Wilfred Maloney, P. Eng., Municipal Affairs and ask about alternative ways to access the Gas Tax for the town. The clerk manager will contact Kirk Peddle, P. Eng., DMG and inform him about the phone lines that will have to be raised before construction can begin on the road and area

for the tower. The second Phase of the Water and Sewer Project will have to be applied for through Municipal Affairs the clerk manager will contact Kirk Peddle and request a price on DMG doing the application.
