All Vacant land that can be connected to the town

water/sewer will be charged \$250.00 for sewer tax \$200 for water as per Municipalities Act 1999 Chapter M – 24 Section 130. "A Council of a municipality served by a water system, sewage system or a water and sewage system shall impose upon the owner of real property located inside or outside the municipality that is connected or is capable of being serviced by that system, a tax, to be known as the water and sewage tax.

All parcels of land will now be charged a minimum of \$300, as per Municipalities Act 1999 Chapter M – 24 Section 112. This means if you have more than one piece of property you will have to pay the minimum of \$300.00, for each additional piece, as per regulations.

Residential Property Tax Discount

Low Income Reduction – Homeowners are eligible for the following reduction in their Residential property taxes provided that the TOTAL Income into the household is as shown below. Income is deemed to be household income from all sources, including both spouses and adult children, rental income etc. No homeowner will pay less than the \$300 minimum plus the water/sewer tax.

Tax Arrears from Previous Years

Thank you to all the tax payers who are making a worthwhile effort to pay their taxes it is very much appreciated. Please be advised that the council will have to make a conscious effort to collect all taxes owing to the town and in doing so Court proceeding will be taking place. Council feels it is the only way that all residents are treated in a fair and equal state. When budgets are done it is on the bases that everyone pays their taxes to keep the town running. Sorry for any inconvenience this may cause, but the new Tax Recovery Plan implemented by the Provincial Government gives the council no other choice. Pay up now to avoid those expensive court charges that will be added on the amount you owe.

The reduction will be based on the preceding year's income. Applicants will complete a form indicating their total household income for the year. They must verify their income with the Town by providing copies of Revenue Canada Assessment Notices for the previous year when they become available. After the income is confirmed, the credit amount will be adjusted on the taxpayer's account.
