BUSINESS ARISING: January 8, 2024

Capital Works — Deputy Mayor Harmon report- talked to MHA, Lloyd Parrot, who informed council that he will approve Phase II application for the town, the only reason it was not approved last year was that, the first Phase had not been completed. DM Harmon talked to Douglas Short, Allnorth and Ryan Chaulk, Newfoundland Power, their concerns: with the erecting of the poles to the tower Mr. Short has a concern if the contractor installing the poles are going to blast due any damage that could occur to the infrastructure already in the ground, and where the pegs are placed to erect the poles could be a problem with snow clearing and accessing the tower with large equipment if needed. Mr. Chaulk informed council that the contractor assures council, that they will not blast, but use another method to access the depth needed for the poles. They will be adding two guide wires to the pole to stabilize it and they will need to be fastened to the granite as well. Council request Deputy Mayor Harmon go back to Newfoundland Power and request that the poles be placed in a different location to service the tower or maybe underground wiring not near the existing waterline pipes but to the side of the road. This would ensure that the area would be accessible. DM Harmon will report back to Council on the response next meeting.

Council has not received a cheque from government for last invoice sent from Cougar, the clerk will pay this invoice as soon as the money arrives from the government.

Fence review — Councillor Higdon has looked at the pump house and well area to estimate on the amount of fencing that will be needed and feels it will be less than what was estimated, exact measurements will be taken and new estimates will be discussed when weather permits.

Financial Report — Clerk's financial report: Amount is bank accounts as of today Scotiabank - \$28,289.92 MCW - \$4,889.69 Gas Tax - \$13,973.17 and regular account \$148,157.41 for a total \$195,310.19. The 2024 Property Tax invoice will be in the mail as soon as the budget is approved by the Department of Municipal Affairs.
